Overview:

On September 20, 2016, the project team for Shaping Our Future met with Regional Thought Leaders – community activists and leaders in the Upstate. The goals of the meeting were to introduce these leaders to the Shaping Our Future effort, discuss broad growth challenges facing the region, and identify key quality of life aspects our region must strive to maintain as we grow.



A presentation by the project team was followed by a discussion on topics related to quality of life. Attendees brainstormed a list of quality of life factors that should be protected as we grow.

Quality of Life Factors

The group brainstormed a list of factors necessary to protect and maintain the Upstate's high quality of life as the region grows. Each participant was then asked to individually rank the factors on a scale from 1 to 5 – with 1 impacting quality of life to the greatest degree (almost a “must-have”) and 5 being less influential. The consultant then compiled the rankings. The factors below are listed with the most influential (according to the group) at the top of the list.

This information will be provided to the Shaping Our Future Steering Committee and will help inform the project as it proceeds. Specifically, information generated during this focus group session will help inform the selection of up to ten major “themes” representing important growth and development issues and opportunities for Upstate leaders to consider as we grow. After themes are determined, performance measures representative of each theme will be evaluated across four distinct future growth scenario alternatives. A “Growth Choices Report Card” will be prepared to illustrate the impacts and trade-offs associated with each selected theme across four potential future growth scenarios.

Alternative Growth Scenarios:

The consultant noted that this effort will build on past regional efforts which have resulted in the collection of 15,000 opinions/value statements from residents across the Upstate regarding future growth. One of those past efforts was the Urban Land Institute Reality Check facilitated in 2009 with more than 400 Upstate leaders. That effort resulted in the identification of four distinct potential future land use patterns: Dispersed, Compact, Corridor and Rural Village Development. The Shaping Our Future effort will build on these conceptual scenarios to bring them to the level of specificity needed to utilize a model to identify trade-offs and comparative impacts among them. General Comments:

Several comments were voiced during the meeting that will also be taken under consideration as the effort moves forward. A brief summary of the comments offered by participants follows:

- **Study Outcomes:** It was noted that many studies/planning efforts fail to get traction that results in meaningful action. Therefore, we must ensure a solid plan for action will come from this effort. The consultant explained that while we are building on many past efforts, this effort is meant to “build the case” for future action and change. It was also brought up that many regional studies of this type focus too squarely on urban areas versus rural, and the group was reminded that we must focus on both as we are truly stronger together. Finally, one participant suggested that the effort remain focused on identifying incentives versus “hard regulations” to accomplish goals.
- **Trend Growth Pattern Identification:** There was concern around how trend growth patterns would be identified in counties lacking updated future land use and comprehensive plans. The consultant explained that in those cases, he would work closely with local planners and other community representatives to identify how and where growth was occurring to inform the trend growth scenario. He also explained that the Technical Advisory Committee for this effort was the Upstate Professional Planners – a group convened regularly by Ten at the Top and composed primarily of planners across the region.
- **Difficulty Quantifying Quality of Life:** There was discussion regarding how to quantify the value of some quality of life aspects – natural beauty for instance – and that doing so effectively will be difficult. It was noted that Upstate Forever is currently working with Furman University to identify Critical Lands for future protection across the Upstate region.



- **Alternative Scenarios Discussion** - The consultant asked the group – in regards to the alternative scenarios that will be developed – how distinct the scenarios should be. It was noted that there would be more value derived from the effort if the alternative scenarios showcased truly distinct patterns of growth (to highlight trade-offs with each scenario). It was also noted – in regards to scenario development – that the group could consider using scenarios prepared as a part of the Strom Thurmond Institute Upstate Growth Study effort.
